## **Conditions and Terms**

## **Cancellation Policy:**

Travel arrangements cancelled 61 days or more prior to departure will incur a \$40 administrative fee, per person. Travel arrangements cancelled 31-60 days prior to departure will forfeit travel deposit(s). Travel arrangements cancelled 30 days or less prior to departure will be charged hotel/supplier expenses that are not recoverable, or 50% of the tour cost, whichever is greater.

# **Event Cancellation:**

If a tour must be cancelled due to unforeseen circumstances or due to insufficient participation, all monies paid will be refunded. Any airline cancellation/change costs or vehicle mileage costs getting to the tour departure location will be the responsibility of tour participants. Tour cancellation notification will be made to tour participants by American History Tours (AHT) no later than 30 days prior to tour departure. Minimum participation requirements are noted for each tour, but will typically be five participants.
